## Council Endorses Plan Monday To Reopen Additional City Facilities

Several additional City outdoor amenities are included in the second phase of our restart scheduled **to take effect Friday May 29, 2020**. Outdoor public washrooms and basketball courts are set to reopen on Friday, with reception areas at City Hall, Building and Bylaw Services and Public Works to open on Monday June 1.

Both the Cranbrook Public Library and reception at Western Financial Place are expected to remain closed to the public until at least July.

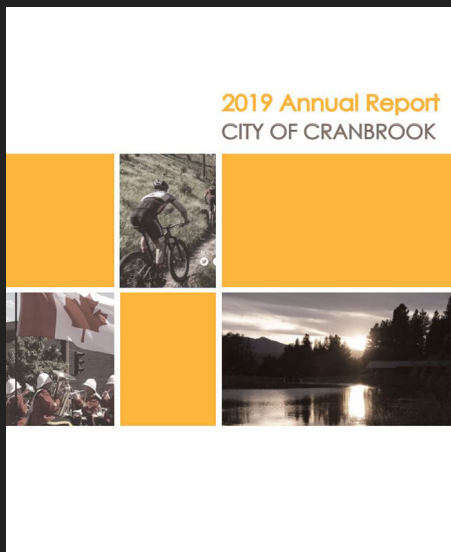

### BMX Track Rebuild Update

The Statements of Financial Information (SOFI) reports are a regulatory requirement for all British Columbia municipalities, to be submitted by June 30 each year to the Ministry of Community, Sport and Cultural Development.

The 2019 SOFI reports include the unaudited schedules showing remuneration paid to the Mayor and Council, a listing of municipal employees and their positions who have remuneration over \$75,000, a list of suppliers of goods and/or services to which the city paid a total of more than \$25,000, and schedules related to debt, severance and guarantee agreements.

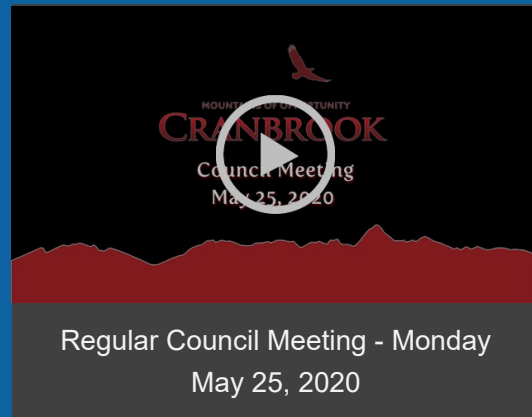
