- 2. Proof of registration and proof of applicant address shall be produced by the occupant of the vehicle displaying a permit upon request of:
 - a Bylaw Enforcement Officer

5. A "Residential Parking Permit" was issued to:

- a Parking Control Officer
- a Member of the Royal Canadian Mounted Police or
- any person duly authorized to assist the above noted persons
- 3. As the holder of a "Residential Parking Permit" I shall abide by the regulations set out in the "City of Cranbrook Streets & Traffic Bylaw No. 3021, 1991" as amended.
- 4. The "Residential Parking Permit" shall no longer be valid upon determination of any of the following circumstances:
 - the holder of the permit ceases to be a resident of the place described in the application or on the permit
 - the vehicle licence number is changed or the vehicle itself ceases to be registered to the place described in the application or on the permit
 - the permit is altered in any manner so as to mislead or is damaged so as to be illegible or is obscured from the interior of the vehicle so as to be illegible to an investigating officer
