• Building Permit Summary for the 1st Quarter of 2020 (January \rightarrow March)

The first quarter of 2020 saw a total construction value of \$28.4 million (51 total permits) as compared to \$3.5 million (44 total permits) for the first quarter in 2019.

The first quarter of 2020 saw 13 new "stand-alone" SFD housing starts in addition to a Multi-family four-plex residential building located along 5th Ave S, for a total of 17 new dwellings. Also, construction of new student housing began at the College of the Rockies which will culminate in 100 student beds (not included in the Suites by Quarter-2020 chart below).
